REQUIREMENTS FOR SPONSORSHIP LICENSURE

To avoid delays, please submit required documentation along with the application:

- 1. Applicant must hold an active NM Tattoo Artist or Body Piercing-Scarification license for a minimum of 5 years with no disciplinary action
- 2. Must work and identify a NM licensed establishment where training will take place
- 3. Must submit a completed application
- 4. Application fee (Non-refundable), accepted payments are money orders and cashier's checks. *PERSONAL CHECKS ARE NOT ACCEPTED*.
- 5. Attach a 1.5 x 1.5 passport quality photograph (head only), taken within the past three months.
- 6. Proof of age A photocopy of driver's license is acceptable. Do not send originals.
- 7. Curriculum must be included and shall include:
 - Training references and resources to be used
 - Methods of evaluation for each area
 - Total breakdown of training hours as defined in 16.36.2.14 for Body Scarification, 16.36.2.15 for Tattoo Artists and 16.36.2.16 for Permanent Cosmetics:
 - 1400 Hours for Tattoo Artist
 - 1200 Hours for Body Piercing
 - 255 Permanent Cosmetics
- 8. Applicant must take and pass the attached State of New Mexico jurisprudence exam.
- 9. Upon approval of application, a board approved log will be available on the board's website to record progress throughout the apprenticeship and will serve as proof of completion of the training program.
- 10. Upon completion of the apprenticeship training program, the sponsor shall submit the notarized log and apprenticeship completion statement to the board office within 30 days.
- 11. Sponsor will give copy of notarized log and statement to apprentice.

You are prohibited from practicing as a tattoo artist or body piercer sponsor until you have obtained a license
