Electrical Permit Application Instructions

PART I RESIDENTIAL

- New construction, addition or renovation electrical permit fee is based on the Service size (in amperes) for new construction or Panel size (in amperes) serving the addition or renovation. This permit fee includes one rough-in inspection (including service) and one final inspection. Additional inspections may be obtained by paying an additional \$27 per inspection.
- Swimming pool permit fee is based on the size of panel (in amperes) serving the pool equipment. This permit fee includes one pool bonding and one final inspection. Additional inspections may be obtained by paying an additional \$27 per inspection.
- Low voltage wiring permit fee for new construction, addition or renovation is based on the type of system installed. This permit fee includes one rough-in and one final inspection. Additional inspections may be obtained by paying an additional \$27 per inspection.
- PV System or Wind Turbine System permit fee is based on the kW equivalent to the Service/Panel size (in amperes) category. This permit fee includes one rough-in and one final inspection. Additional inspections may be obtained by paying an additional \$27 per inspection.
- Temporary Power Pole permit fee is for an underground or overhead temporary service. This permit fee is for one inspection only.
- Manufactured Home permit fee is for a single service serving a manufactured home only. This category does not apply to electrical services serving other loads such as garages, wells, barns, etc. This permit fee is for one inspection only.
- Service Change Only permit fee is for a service that is repaired or replaced with the same amperage size rating. This does not apply to service upgrades in voltage or amperage size or for any electrical wiring performed in the building. This permit fee is for one inspection only.
- Minimum Inspection Fee is for Items not Listed includes any other type of electrical wiring or for an additional inspection needed. This category does not include wiring on an addition or renovation. This permit fee is for one inspection only.
- Customer Owned Distribution permit fee includes customer owned service lateral or feeder and is based on a minimum fee plus number of poles installed or number of feet of trench. This permit fee includes rough-in(s) and final inspection.

PART II COMMERCIAL

- New construction, addition or renovation permit fee is based on the Service size (in amperes) for new construction or Panel size (in amperes) serving the addition or renovation. This permit fee includes rough-in(s) and final inspection(s).
- Swimming pool is based on the size of panel (in amperes) serving the pool equipment. This permit fee includes pool bonding, rough-in(s) and final inspection(s).
- Low voltage wiring permit fee for new construction, addition or renovation is based on the type of system installed. This permit fee includes one rough-in and one final inspection. Additional inspections are obtained by paying additional \$27 per inspection.
- PV System or Wind Turbine System permit fee is based on the mW equivalent to the Service/Panel size (in amperes) category. An additional Customer Owned Distribution permit may be required. This permit fee includes rough-in(s) and final inspection(s).
- Temporary Power Pole permit fee is for an underground or overhead temporary service. This permit fee is for one inspection only.
- Service Change Only permit fee is for a service that is repaired or replaced with the same amperage size rating. This does not apply to service upgrades in voltage or amperage size or for any electrical wiring performed in the building. This permit fee is for one inspection only.
- Minimum Inspection Fee for Items not Listed includes any other type of electrical wiring or for an additional inspection needed. This category does not include wiring on an addition or renovation. This permit fee is for one inspection only.
- Customer Owned Distribution permit fee includes customer owned service lateral or feeder and is based on a minimum fee plus number of poles installed or number of feet of trench. This permit fee includes rough-in(s) and final inspection(s).
- Customer Owned substation or generating station permit fee is based on the mW equivalent to the Service/Panel size (in amperes) category. This permit fee includes rough-in(s) and final inspection(s).
