The mission of the New Mexico Real Estate Commission is to protect the public and enhance the professional competence of real estate brokers. The New Mexico Real Estate Commission was created by state law in 1959 and charged with enforcing the Real Estate License Law and the Real Estate Commission Rules.

"Except for brokers who are exempt from continuing education by virtue of having attained 65 years of age and a minimum of 20 years of continuous licensure prior to July 1, 2011;" (emphasis added) all licensees are subject to:

- (1) 36 total hours CE each 3-year cycle,
- (2) 4 hours of ethics, and
- (3) 12 hours of the annual core course. [See Further Core Course Explanation below.]
- (4) Associate Brokers must have 4 hours of "core elective" credits.
- (5) Qualifying Brokers must take 8 hours of "core elective" credits, and
- (6) Qualifying Brokers must also take: Qualifying Broker Refresher, and attend a Commission meeting or a Commission Disciplinary hearing.

CORE COURSE REQUIREMENT

All Brokers must complete the annual NMREC Core Course requirement. The NMREC Core Course requirement is 4 hours <u>each year (annual) of a licensee's cycle (12 cumulative hours of the NMREC Core Course series</u>. The word "annual" is always defined strictly as having completed 3 separate annual calendar year iterations of the core course within a set 3-year cycle. Core Courses are issued each calendar year with a title prefaced by that year's calendar year (i.e. 2020 NMREC Core Course). Three 4-hour core courses accumulate to 12 CEU hours per full 3- year cycle.) The Licensee will see in this Core Course Planning Guide that the accomplishment of the requirement for most licensees affords them 2 options for achieving the requirement.

PENALTY FOR NOT TAKING AN ANNUAL ITERATION OF THE CORE COURSE

A transition period of three years has been necessary to allow licensees to get used to the requirement of having to take an annual Core Course. During that 3-year phase, someone who missed an "annual iteration" (issued by calendar year) of the core course was given opportunities to take "makeups" of a particular year's issued core course based upon Core Course instructors' willingness to offer those makeups. The makeups were basically market driven. Through the middle of 2019, there was one instructor offering "makeups" for the 2017 core course year. Through November of 2019, there are still 2018 core course makeups available.

But after December of 2019, instructors should use discretion in terms of offering makeups for any core course not taken in a particular year. Core Courses are issued to be taken that Calendar year and only in extenuating circumstances should a makeup core course be offered.

Penalty: Beginning January 1, 2020, there will be a renewal penalty for missing any year's core course within the licensee's three-year cycle. The penalty will be to take the 30 classroom hour Broker Basics course for 0 CEUs. If two annual iterations are missed, that would call for a second 30 classroom hour Broker Basics course for 0 CEEUs to be taken within the same cycle -- just in order to renew. The penalty is severe especially now that licensees should have already become used to fulfilling this important requirement.

The two most common causes of licensees missing a core course are: 1. Waiting until the last minute to find an available course, and, 2. Simply not knowing the Rules of the Real Estate Commission. Inactive licensees have the same requirements and must begin to pay better attention to fulfilling these requirements.

Distance Learning is in the Future of the Core Course

The Commission hopes to introduce distance options that will enable licensees in remote areas to comply with the annual core course requirement. Most notably, we are exploring streamed core courses using common platforms. We expect to have these options within the 2020 Calendar year; at least that is our hope.

PROPERTY MANAGER CONTINUING EDUCATION REQUIREMENTS

As of January 1, 2019, anyone who has submitted a Property Management Declaration is subject to those requirements. Those requirements differ between Qualifying Brokers and Associate Brokers but are meant to be accomplished within the context of the 36-hour minimum CE requirement for renewal which includes the specific ethics and core elective

requirements. Property Management educational requirements are not meant to be additive to, but rather, inclusive within the 36-hour minimum educational requirement. Property Management electives including "core electives" and "ethics" designated courses are meant to serve within the context of the 36 hours. EXEMPT STATUS LICENSEES

In the Rules of the Real Estate Commission the Preamble on the Section on Continuing Education (16.61.13.8. Requirements) states:

"Except for brokers who are exempt from continuing education by virtue of having attained 65 years of age and a minimum of 20 years of continuous licensure prior to July 1, 2011;" (emphasis added) -- The Rules then define what those specific requirements in several sections pertaining to the minimum number of hours, annual core course requirements, core elective requirements, and ethics requirements. Thus, Continuing Education requirements apply to all licensees according to the rules unless you meet that statutory requirement.

The only licensees who are not required to take Continuing Education are those who meet criteria noting that they must have met that criteria by July 1, 2011. Anyone achieving both of the criteria AFTER that date are not considered exempt. The effect of the statute's July 1, 2011 deadline is that the number of licensees who meet the standard are few and their numbers decreasing over time. In almost all cases, those who qualify and have qualified for this exemption know who they are already and it is documented in the NMREC records.
