CORRECTIVE ACTION PLAN

A corrective action plan shall be submitted to the CCD within five (5) business days from the date you receive the Corrective Action Plan template from the compliance team. If no violations were found during the inspection you will receive a Close-Out Letter for your records.

If violations are found, complete the Corrective Action Plan template sent by the compliance team. Reply to the compliance team email and attach the completed document. Complete all responses related to the inspection, including the proof of all corrections within the same email chain as the initial inspection checklist that was sent by CCD.

Provide photos, videos, or completed documents, as applicable to the violation corrected, to be reviewed by staff when all corrections have been completed and proof of all corrections is available (No more than 30 days).

Once proof of corrections have been reviewed, the licensee will receive a Closeout Letter in which documents that all violations noted in the inspection conducted have been rectified and that the facility is in compliance and in good standing for license renewals.

Failure to submit corrective action plans and/or proof of corrective actions may result in a revocation or suspension of your license and/or fees and fines. See, Division Action 16.8.12.11

The diagram must show the following: • The boundaries of the property and the proposed premises to be licensed. • The dimensions of each area that cannabis plants will be cultivated. • The location(s) and the dimensions of other areas where other horticulture will be cultivated, if applicable. • As applicable, any equipment to be used entrances and exits, interior partitions location of lights in the cannabis plant cultivation area(s) and the maximum wattage or wattage equivalent, walls, rooms, windows, and doorways. • The diagram shall include a brief statement or description of the principal activity to be conducted in each area on the premises. • The diagram shall show where all cameras are located and assign a number to each camera for identification purposes. • The diagram shall be to scale. • The diagram shall not contain any highlighting markings on the diagram shall be in black-and-white print.	16.8.2.24 (A)(B)(C) (D)(E)

- protocols to ensure that cannabis or cannabis products, including any samples of cannabis or cannabis products, are transported and stored in a manner that prevents degradation, contamination, tampering, or diversion

Employee policies and procedures to address the following minimum requirements:

- adherence to state and federal laws
- responding to an emergency, including robbery or a serious accident
- alcohol and drug-free workplace policies and procedures
- safety and security procedures

- occupational safety
- crime prevention techniques
- confidentiality laws

Documentation prepared for each employee and statements signed by employees indicating receipt and understanding of policies and procedures.

Description

REQUIRED TESTING

Rule 16.8.7.15

Establishment shall segregate a batch of cannabis product and arrange for samples to be collected and tested by a cannabis testing laboratory. The batch must pass all required tests prior to the sale or delivery to a qualified patient, primary caregiver or consumer.

"Batch" means, with regard to cannabis, an identified quantity of cannabis no greater than 15 pounds that is of the same strain of cannabis, that is harvested during the same specified time period from the same specified cultivation area, and with respect to which the same agricultural practices were utilized, including the use of any pesticides; and with regard to concentrated and cannabis product, means an identified quantity that is uniform, that is intended to meet specifications for identity, strength, and composition, and that is manufactured, packaged, and labeled during a specified time period according to a single manufacturing, packaging, and labeling protocol. 16.8.1.7 (B)

Water: If using for irrigation water from a non-municipal source, a cannabis establishment shall maintain quarterly testing data indicating concentrations at or below the action levels in Table 1, Heavy Metal Testing Requirements for Water and Soil, below.

TRACK AND TRACE SYSTEM PROCEDURES

Conformity of use: licensees must utilize the track and trace system in conformance with division rule and track and trace system procedures. Track and trace procedures include:

Rule 16.8.7.14 (A)(B)

- Properly indicating the creation of a harvest batch or production batch including the assigned harvest batch or production batch number.
- Accurately identifying the cultivation room or outdoor location where each plant is located on the licensed premises.
- Accurately identifying when inventory is no longer on the licensed premises.
- Properly identifying cannabis or cannabis products identified as test batch.
- Properly indicating test results from a cannabis testing laboratory.

Description

Description

- Accurately indicating the track and trace system category for all cannabis or cannabis products.
- Accurately including a note explaining the reason for any destruction of cannabis or cannabis products, and the reason for any adjustment in weight or count to inventory in the track and trace system software.
- Properly assigning unique identifying tracking numbers to each cannabis plant, cannabis product and any batch, lot, or sublot from such cannabis plant(s) and cannabis product(s).

GENERAL TRACK AND TRACE SYSTEM USE

Rule

System required: all track and trace activities of a licensee must be tracked through use of the track and trace system. Licensees must reconcile all on-premises and in-transit cannabis or cannabis products each day in the track and trace system by 11:59 p.m. that same day. Track and trace system software must then be synchronized by the licensee prior to closing the session (as applicable).

16.8.7.10

Weights and measures: licensees must utilize a standard of weights and measures that is supported by the track and trace system to track all cannabis or cannabis products. A scale used to weigh product prior to entry into the track and trace system shall be certified to be registered and calibrated in accordance with applicable requirements of the New Mexico department of agriculture.

System security: licensees shall maintain the security of the track and trace system, as follows:

- -maintain an accurate and complete list of all track and trace system users for each licensed premise
- -update this list when a new track and trace system user is trained or when an existing user is removed;
- -train and authorize any new track and trace system users before they may access track and trace system or input, modify or delete any information in the track and trace system

the track and trace system or otherwise conducting cannabis or cannabis product inventory tracking activities.

-cancel any track and trace system administrators and track and trace system users from their associated track and trace system accounts once any such individuals are no longer employed by the licensee or at the licensed premises. **Responsible for employee actions:** licensees are accountable for all actions employees take while logged into the track and trace system or otherwise conducting cannabis or cannabis product inventory tracking activities. Responsible for individual actions: each individual user is also accountable for all of their actions while logged into
