Notice of Proposed Rule Hearing – Cannabis Control Division

The New Mexico Regulation and Licensing Department, Cannabis Control Division (CCD), will hold a public rule hearing on:

Location: Rio Grande Conference Room, Toney Anaya State Office Building, 2550 Cerrillos Road, Santa Fe, NM

This hearing is to receive public comment on proposed rule changes, including the creation of a new rule (16.8.9 NMAC) on the Embargo, Recall, and Seizure of Cannabis, along with amendments to various existing rules affecting all license types.

Public Comment Period: Began on July 29, 2025 Ends at the conclusion of the hearing on September 3, 2025
