I have read and understand the Sale of Recycled Metals Act , NMSA 1978, §§ 57-30-1 to -14 (“the Act”), and that it is my responsibility to comply with all requirements of the Act, and to ensure that my employees comply. I understand that I must view the Act to see my compliance obligations, and that I may be penalized for violations. I have read and understand the regulations (“rules”) pursuant to the Act, 12.2.15 to 12.2.18, and that it is my responsibility to comply with all of the rules, and to ensure that my employees comply. View the Rules .	
I understand that I may not buy or sell Regulated Material, which includes Restricted Material, without a valid and current registration issued by the department, and that I am responsible for renewing my registration prior to its expiration date.	
I have registered with the metal theft alert system at http://www.scraptheftalert.com as required, and I will keep all employees apprised of alerts in compliance with NMSA 1978, §§ 57-30-2.3(A)(3) and (A)(4) .	
I affirm that I am in compliance with all federal requirements for scrap metal dealers, including maintaining storm water permits , in compliance with NMSA 1978, § 57-30-2.3(A)(2) .	
I understand that ALL purchases of Regulated Material, which includes Restricted Material , require the seller’s information to be recorded on a Purchase Record form provided by the department , and that the documentation must include all information listed under NMSA 1978, § 57-30-5(B) . “Visual verification” means I must compare the ID with the actual person or vehicle ON EACH OCCASION OF SALE, and I must not rely on my “system”.	
I understand that no transactions of Restricted Material shall be made without ADDITIONAL written documentation that the seller is the rightful owner, has permission from the rightful owner to sell the material, or that the material was lawfully obtained, in compliance with NMSA 1978, § 57-30-2.4(A) .	
I understand that ALL purchases of regulated material must be reported by uploading to the department database (Reporting System) by the second business day after purchase, in compliance with NMSA 1978, § 57-30-8 . I agree that purchase includes acquisition, trade, or any method by which I obtain the material.	
I understand that Regulated or Restricted Material that is suspected stolen or unlawfully obtained must not be removed from the premises and that I must report it to a local law enforcement agency with 24 hours, in compliance with NMSA 1978, § 57-30-2.3(B) .	
I understand that each Purchase Record shall be preserved on site for one year at the physical place of business indicated herein , from the date the record was made, as set forth in NMSA 1978, § 57-30-6 and produce to a peace officer upon request as set forth in NMSA 1978, § 57-30-7(A) .	
REQUEST FOR BUSINESS INFORMATION: I understand and agree that I will produce within 48 hours of request by the RLD Recycled Metals Program a copy of my business license or tax ID number, or both.	
Changes in application information: I understand that any changes in the address, name, or ownership, or the CLOSING of the business for which application for a Recycled Metals registration is applied herein shall be reported to the department no later than five (5) days of their occurrence. I further understand that any substantial change in ownership, including a change in a listed partner/member of a partnership, LLP, or LLC will necessitate the submission of a new application.
