

Guidance regarding introduction of New Mexico Mobile ID

Dear Licensee:

This letter is to inform you that the [New Mexico Motor Vehicle Division \(MVD\) will begin offering mobile IDs](#) which will allow residents to present New Mexico-issued driver's licenses and state IDs digitally via a digital wallet on a mobile device. New Mexico joins nearly a dozen other States already issuing Mobile IDs.

To aid businesses who must verify age before allowing for the sale of certain products including alcoholic beverages or tobacco products, the MVD has launched Mobile ID Acceptance on iPhone with [NM Verifier app](#).

Now businesses can verify Mobile IDs with only an iPhone and the NM Verifier app, no additional hardware or physical readers required. Licensed establishments can also choose another ISO 18013-5 compliant reader. By simply using NFC technology or scanning a QR code, licensees can validate a customer's Mobile ID is state-issued and valid.

Under [NMSA 1978, Section 60-7B-2](#) and [NMSA 1978, Section 61-37-14](#), Documentary evidence of age and identity, using NM Verifier for iOS or other mobile verification applications to accept Mobile IDs is a compliant method of age verification and is approved for use by the New Mexico Regulation and Licensing Department and the Alcoholic Beverage Control Division. When a customer purchases alcoholic beverages or tobacco products and presents their Mobile ID, licensees can use Mobile ID Acceptance on iPhone with the NM Verifier app, or another ISO 18013-5 compliant reader to verify the consumer's age. A customer cannot "show" their Mobile ID to a business or server.

PLEASE NOTE: It is up to each licensee to determine what method(s) they use to verify age in order to stay compliant with relevant laws. Licensees are not required to accept Mobile IDs or utilize the NM Verifier app or other mobile verification apps; it is simply an option as the adoption of Mobile IDs continues to grow. Licensees are reminded to never sell alcoholic beverages or tobacco products to individuals under the legal age.
